

**ORDINANCE No. 2020-2021-04
SINGLE TOWNSHIP ROAD DISTRICT
TAX LEVY ORDINANCE**

An ordinance levying taxes for all road purposes for the Lemont Township Road District, Cook County, Illinois, for the year 2020.

BE IT ORDAINED by the Board of Trustees of Lemont Township, Cook County, Illinois, as follows:

SECTION 1 That the Highway Commissioner of Lemont Township Road District on December 08, 2020 does hereby determine and declare that the sum of One Million, Two Hundred Three Thousand, Three Hundred Eighty-One Dollars and Sixty-Three Cents (\$1,203,381.63) is hereby levied upon all property subject to taxation within the road district as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the road district as required by statute or voted by the people in accordance with the law, for such purposes as:




