The Pledge of Allegiance was said and roll was called by Township Clerk Barbara A. Buschman: Blatzer, Lemming, Molitor, Virgilio and Shackel – present.

A motion was made by Blatzer, 2nd by Molitor to approve the minutes of the September board meeting; On roll call: Blatzer, Lemming, Molitor, Virgilio and Shackel – ayes. Motion Passed.

Matters from the Public.

Patricia Frederikson spoke in regards to the ditch at the side of her house. Jeanette Daubarus spoke about Open Space and putting private office on that area on Alba Street and having an Amendment to the State Statute. Also that there should be a public hearing. Supervisor Shackel mentioned it had happened.

Reports: Supervisor Shackel reported on a Symposium meeting he attended with TOCC. Reported on a meeting in regards to Foundations. Spoke to attorney and will check in on it. Chief Maton reported on village siren in on Township property. George Shaefer is on a timetable in regards to the Village Walking path for Spring. The Annual Audit will be at the November meeting. He obtained drawings for the Alba addition from Simon Batistich, and is hoping to receive the bid package by the end of next week

Highway Commissioner: In Mark Labno's absence it was reported paving has started in Emerald Acres.

Clerk: Barbara A. Buschman reported that a flyover was done by ABC Channel 7 at the Lemont High School last week.

Assessor: Mario Mollo reported that Cook County tax bills will be in the mail on November 1st, due on December 1st. There were 450 appeals. Appeals are open from October 5 to November 3.

Human Services: Stephanie had six families certify for the food pantry. One family filed for financial assistance. The Scarecrow Fest was a huge success. She met with 15 residents in regards to the Senior and Disabled Support Grant. The Senior Association is having a Halloween party on that day. Also sent memo to food pantries for names for the Christmas Giving Tree.

Facilities and Open Space report: Glenn Pasiewicz reported that Alda has been busy with 11 activities going on including a Village lunch. A 1 Mechanical has installed new heating and air conditioning at the Warner Avenue building. Thanks to Jim Helbig and Michael Smollen for work done around the Township. The dog park has been reseeded and aerated. Centex will be doing the cleaning. November 21st will be the last Sanctuary cleanup. Pizzo is winding down for the season.

Transportation: Marybeth Nunzio reported on 160 seniors and 63 handicapped residents totaling 223 one-way trips. September PACE quarterly inspection passed. Mike Fricka passed Pace paratransit training and is on the October schedule as backup. The October schedule will now include Thursdays. We had 10 Vanpool riders for September and passed the PACE vanpool drug and alcohol Audit. We are in need of vanpool drivers and will post on website and facebook.

Administrator Report: Mario Mollo gave much thanks to the staff for all of their hard work all of September. Cindy is saving us at least 10% on Amazon business. She is also looking at grants. An Eagle Scout is looking at work to be done at the dog parks with fencing and dog-friendly mulch.

New Business: Trustee Lemming referred to work on 132nd Street which has been point of discussion for some months and asked if the road was going to be rebuilt. Shackel is not sure and referred him to Labno. They did go over to Mr. Mendenhall's property and cut a trench. It seemed to help and discussion was held.

Administrator Mollo and the Board congratulated Clerk Barb Buschman on achieving her 85th birthday over the week-end and all sang Happy Birthday to her. She was very appreciative of this and thanked everyone.

A motion to adjourn was made by Lemming, 2nd by Blatzer at 8:20 p.m. On roll call: Blatzer, Lemming, Molitor, Virgilio and Shackel – ayes. Motion passed.





Lemont Township Building Report

October 2023

During the Month of October, we had 17 rented meetings at both the Community Center and the Warner Ave building, including our 2nd Cook County Tax Workshop.

Sanctuary, Community Center & Warner Update:

- 1) A-Plus Fire Protection Service serviced and refilled the fire suppression hood system at the Community Center. Unless activated, the system should be up to code for several years to come.
- 2) Thank you to Kathy Henrikson, Bill Cross, Erik Attaway and all the LHS Volunteers that helped clean and maintain the Sanctuary property at our final clean-up of the year on Saturday October 21st.
- 3) A big thank you to Mike Smollen and Jim Wojnarowski from the Highway Department for helping us transfer the 3 winning scarecrows down to the Safety Village for the Halloween Hoedown on Saturday October 28th. Also, thanks to the crew for spreading mulch around the Lions beehive in our Sanctuary, as well as spreading crushed stone along the LJWC walkway.
- 4) Davey Tree Service and Asplundh Tree Service trimmed, cut, and ground up branches, trees and stumps that were along the East boundary of our property that butted up against the backyards of several Timberline homes. Many of these trees and branches were overtaking the ComEd powerlines.
- 5) In discussions with Beechen & Dill to connect our Sanctuary walkways with their new Copper Ridge Development.
- 6) We met with architect Simon Batistich to review our initial set of working blueprints for the Community Center in preparation for our TRC meeting with the Village of Lemont.
- 7) Cintas has installed cleaning product dispensers in the custodial closet at the Community Center.
- 8) Metropolitan Sprinkler Company performed the annual inspection test on our sprinkler system at the Alba CC. (We passed and are good for a full year)

Dial-A-Ride Program/Vehicle# 22100:

We assisted 208 seniors and 82 handicapped residents, totaling 296 one-way trips in October. (203 fares were subscriptions.)

I had 13 families certified for the Food Pantry this past month. 12 new families, the others were recertified.

I received 2 application this month for financial assistance, I am currently waiting on documentation from both to further review for assistance.

The Senior and Disabled Support Grant is completed. I gave out a total of \$3800 in assistance, meeting with a total of 38 residents.

LIHEAP is going well, I have met with 47 residents, and completed applications for all of them. Last year, we only serviced 40 residents all year long for LIHEAP so we are much busier with it now.

I have assisted 1 residents getting the Benefits Access program to get a lower license plate sticker cost. It was recently lowered even more from \$24 to \$10

The Senior Association hosted their Halloween Party, there were about 40 residents registered.

The Senior Association is also hosting their Christmas Lunch on December 13th at the Crystal Grand Ballroom. If any board members are interested in attending, please let me know as soon as possible. There will be entertainment by Quintin Flagg.

This week we will be handing out the gift cards for the Thanksgiving Dinner. I will also be putting up the Giving Tree at the Core. We do not have nearly as many children registered as in the past so I decided to add on our seniors 65 and older who utilize the food pantry.
