Matters from the Public: Mark Jouzapitis of 13075 Parker Rd. voiced his concern over what the Township was doing about the Concealed Weapon Amendment to gun legislation under the jurisdiction of the Township. Rosendahl said the Township has no jurisdiction and he should get in contact with Cook County Board member Liz Gorman. Discussion ensued with no action taken.

SUPERVISOR REPORT:

Rosendahl reported that Kops n Kids went well. Township had a table at the event. Keepataw Days is over the Labor Day week-end and the Township will be in the parade on Monday. It is the 65th anniversary of it and if more funds do not become available, it may be the last one. Heritage Fest was sponsored with the Village and the turnout was good.
