Lemont Township Board Meeting - December 10, 2013

Lemont Township Board Meeting was called to order by Supervisor Rosendahl at 7:00p.m. at the Township Office, 1115 Warner Avenue at 7:00 p.m. on December 10, 2013. The Pledge of Allegiance was said and Roll Call was taken: Nicklas, Ptacek, Taylor, Wozniak and Rosendahl-Present. Also in attendance were: Sig Vaznelis, Road Commissioner; Township Assessor Jacobowski; and Nancy Hoinacki, Township Administrator

Motion was made by Nicklas, 2nd by Wozniak, to approve the minutes of the November 13, 2013 meeting. Motion approved by voice vote.

Motion to approve the Treasurer's Report and Payment of Bills made by Taylor, 2nd by Wozniak. On roll call: Nicklas, Ptacek, Taylor, Wozniak and Rosendahl-aye, motion passed.

Reports: Supervisor Rosendahl reported that he and others took a trip down to tornado-ravaged, Washington, IL. He explained how they worked the volunteers. They were sent to pick-up the debris out of the farmers' fields. They toured the subdivisions that were devastated, the local churches where the hub for food, volunteers, etc. were. The Township was audited by Pace, which included testing for those who may be on drugs and/or alcohol.

Just for information, he shared the news that the group who had restarted Keepataw Days could no longer keep the event going. The money just isn't there. Rosendahl has been in contact with the Mayor regarding the situation. Also, there will be a meat raffle held at Stonecutters on Sunday to benefit the Township Family Assistance Fund.

Highway Commissioner: Vaznelis reported that the Township salted Sunday when we had a minor ice/snow storm. Reported that the price for road salt (Morton Salt Co.) are the same as last year, \$51.14 a ton. The Township was reimbursed \$70,000.00 from MFT funds.

Human Services: No report, other than the giving trees for children in need were put up around the Village. Also, looking for volunteers to ring bells on assigned weekends for the Salvation Army. Township gets to keep the money collected on those weekend. The Classic Car Group had their annual Christmas Party at the Alba building for Lemont children in need.

Assessor: Jacobowski reported that homeowners have until January 31st to file for tax exemptions. The County is checking out homes and people who are not entitled to some. If a renter pays the taxes on a home they are renting, they are entitled to the homeowners exemption. They have found 14,000 people who are deceased but have been getting the senior freeze.

Clerk: Buschman thanked Administrative Assistant, Elizabeth Ganta, for filling in for her at the last meeting.

Open Space: Henrikson reported that master-gardeners from U of I, Will County and Cook County are looking into giving information on how to manage the open space property on a long-term basis. Nicklas asked about volunteers attending training classes as was mentioned before. Lastly, Com Ed is coming out to the Alba Street building to work on the lights.

Old Business: Motion was made by Wozniak, 2nd by Ptacek, to approve Ordinance No. 2013-2014-06, Tentative Township Tax Levy Ordinance. On roll call: Nicklas, Ptacek, Taylor, Wozniak, Rosendahl-aye. Motion passed.

Motion was made by Nicklas, 2nd by Taylor, to approve Ordinance No, 2013-2014-07 Tentative Single Township Road District Tax Levy Ordinance. On roll call: Nicklas, Ptacek, Taylor, Wozniak, Rosendahl-aye, Motion passed.

New Business: Seeing no change in the Pace Agreement, a motion was made to approve Resolution 2013-2014-04 Authorizing the Execution of the 2014 Paratransit Service Provider Agreement. On roll call: Nicklas, Ptacek, Taylor, Wozniak and Rosendahl-aye. Motion passed.

Motion made by Wozniak, 2nd by Nicklas, to adjourn at 7:32 p.m. Motion passed.

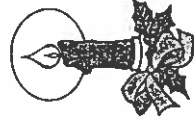
