A motion was made by Nicklas, 2<sup>nd</sup> by Gilbertson to approve the minutes of the March Board meeting. Motion passed by voice vote.

## **REPORTS:**

**Supervisor**: Rosendahl reported that there were no updates on the elimination of certain Township Clerks positions in Will County. The Township Family Day was well attended on May 4<sup>th</sup> at which time the Memorial Bench for Ed Verdetis was dedicated in his honor. A Thank You to Mark Labno, Township Road Commissioner for his landscaping work on the Dog Park area. Also, Rosendahl reported on a Tech Review on 129<sup>th</sup> Street. The Village owns the fence there.

**BOARD REPORTS:** Gilbertson reported that there will be a closed session after the regular Board meeting for the purpose of personnel.

**Highway Commissioner**: Labno reported working from snow to rain, which was no surprise! Archer Avenue & Bella Ln. had 4 feet of water, possibly from a broken field tile and there was no place to pump it to. Our Township engineer is getting a program together of work to be done. Discussion followed.

**CLERK:** Clerk Buschman announce the hosting of the Cook County Clerk meeting is tentatively set for September 5<sup>th</sup>.

**Human Services:** Supervisor handed out reports from Schmitt & O'Neil. He announced that the summer lunch program will also include the high school this year instead of just at the middle schools.

Open Space: Henderson reported on a great Family Day which was on May 4<sup>th</sup>. About 15 high school students came out to work in the Open Space. She is trying to get more volunteers. The Seniors are having a Craft Day and also Zumba on the 2<sup>nd</sup> & 4<sup>th</sup> Tuesday at the Township Community Center.

**Unfinished Business:** Jeanette Virgilio, the Project Manager for The Forge, passed out information and informed the Board that they have a license agreement with the Village. The plan is approved by the Planning & Zoning Commission and will go to the COW meeting next Monday. There were two well-attended community meetings in regards to the project with about 40 at each meeting at the offices on Front Street. Approval is needed from the Village and then construction can start. Virgilio will send maps to the Township.

Cook County Township Day is on June 15<sup>th</sup>. The GA Flat Grant payment increases to about \$350.00; now is \$304.00

Trustee Nicklas complimented Kathy Henrikson on the flyer for the Family Days activity.
