Lemont Township Board Meeting – November 9, 2021

The Lemont Township Board Meeting was held on November 9, 2021 at the Township offices, 1115 Warner Avenue, Lemont, II. 60439. Meeting was called to order by Supervisor Michael Shackel at 7:00 p.m. Roll was called by Clerk Barbara Buschman and the Pledge of Allegiance was said. Trustees Blatzer, Molitor, Nathan and Virgilio and Supervisor Shackel were present.

A motion was made by Trustee Blatzer, 2nd by Trustee Virgilio to approve the minutes of the previous meeting. On roll call: Blatzer, Molitor, Nathan, Virgilio and Shackel – ayes. Motion passed.

Matters from the Public: Jeanette Daubarus inquired about a bad railroad crossing in the Township. There are no railroad crossing in the Township. She was referring to the track going across Boyer Road which is a private, not public, road.

Also, Brian Parker handed out to the Board a vision he has in regards to the Lemont Woodland Sanctuary Expansion. The Board is going to study the report.

REPORTS:

Supervisor Shackel reported that the website is still not opened for taking the Open Meeting Act. He spoke of software for General Assistance which is \$5,000.00 but we received a grant for \$4,000.00. Supervisor Shackel spoke on the subject of the problem on 131st Street bordering Lemont. Shackel has spoken with Norm Anderson from Cook County. Citations have been written and issued by Cook County. Papers are still filed with the Cook County Court System. Also, things have been quiet at the "party house" on 131st Street. With approval of the Board, Patrick Hynes, who is the Assessor in Lyons, will be a temporary Assessor when Assessor Ken Jacobowski's term expires on December 31, 2021. Supervisor Shackel accompanied Human Services Stephanie Covarubias to Rockford for a General Assistance program.

Highway Commissioner: Mark Labno reported that we have plenty of salt for the upcoming season. IDOT charge is \$57.00 a ton now. The Township received \$120,000.00 in MFT funds. Getting the equipment, etc. ready for winter. Supervisor Shackel mentioned that there is an Annual virtual program for Road & Bridge next week and one for the Trustees in January.

Clerk: Clerk Buschman had no report.

Assessor: Ken Jacobowski reported that the 2nd Installment for taxes next year will be late. Also, all appeals have been processed. The First Installment of Property Tax Bills will be on time and delivered in March.

Human Services: Stephanie Covarubias reported that she serviced five new applications for financial aid and one has been approved. She also mentioned attending a conference in Rockford with Supervisor Shackel. Flu shots will be given on November 25th. The senior lunch program is open. Gift cards are being given out for Thanksgiving for those in need. Also, the Christmas giving tree will go up right after Thanksgiving at the Park District. The general assistance program has gone up from \$350.00 to \$400. Eligibility is once every 18 months.

Open Space/Facilities: Kathy Henrikson handed out a report on happenings at the open space and facilities. A Youth Group is meeting monthly at the Warner Avenue facility. Also, 700 votes were cast in the Scarecrow program. The Garden Club took 1st place. The outdoor fireplace needs repairs at the cost of \$2,900.00. The Senior Christmas Party will be on Sunday, December 12 at Cog Hill.

Transportation: Karen Liset handed a report to the Board in regards to costs for the vehicles we have from Pace and in regards to costs of having our own vehicles. We now have 3 vehicles. Really think we only need 2. Will stay with Pace for at least another year. A new bus would be about \$80,000.00. The

Board took the matter under advisement. Trustee Nathan asked for a break-down on costs and riders for next meeting.

New Business: The tentative 2022 Levy for Lemont Township and Lemont Highway Department was handed out. Road Commissioner Labno outlined what needs to be done for the coming year. He will be working on it for the next meeting. Supervisor Shackel stated that the Levy for 2021-2022 is virtually the same as 2020-2021 with a less than \$3K increase in the Levy. Assessor Ken Jacobowski introduced Patrick Hynes to the Board. Jacobowski has known him for 25 years. He is the Assessor in Lyons Township and will work part-time in Lemont; about 10-15 hours a week and will attend Board meetings. This is a temporary situation until a replacement is found for our current assessor.

A motion was made to approve Resolution 2021-22-01.
Assessor Employment Agreement between Patrick Hynes and Lemont Township by Blatzer, 2nd by Nathan. On roll call: Blatzer, Molitor, Nathan, Virgilio and Shackel – ayes. Motion passed.

A motion to adjourn was made by Blatzer, 2nd by Nathan, at 8:20 p.m. On roll call: Blatzer, Molitor, Nathan, Virgilio and Shackel – ayes. Motion passed.
