# New Business:

A. Strand Task Order for the Community Center Parking Lot Construction Services

Supervisor Shackel discussed the task order from Strand, authorizing the firm to continue monitoring the project for an additional fee. He noted that while the agreement is based on a worst-case scenario, the actual oversight costs are expected to be considerably lower. The engineering services are not to exceed \$70,000.

A motion was made by Trustee Blatzer to approve the engineering services on an hourly basis and seconded by Trustee Molitor. A roll call vote was taken. On roll call: Blatzer, Lemming, Molitor, Wilk, Shackel -ayes. Motion passed.

# B. Discussion of Youth Services

# Task Order No. 25-02 Lemont Township, Illinois (OWNER) and Strand Associates, Inc.® (ENGINEER) Pursuant to Agreement for Technical Services dated September 11, 2017

#### **Project Information**

Services Name: Community Center Parking Lot Construction-Related Services

Services Description: Provide construction-related services for the Community Center Parking Lot reconstruction at 16300 Alba Street, designed by ENGINEER.

#### Scope of Services

ENGINEER will provide the following services to OWNER.

- Provide contract administration services including attendance at the preconstruction conference, review of up to two iterations of contractor's shop drawing submittals, review of and response to contractor's requests for information, review of up to four contractor's periodic pay requests, attendance at up to four construction progress meetings, up to four periodic site visits, and participation in project closeout.
- 2. Provide a resident project representative (RPR) for part-time observation of construction. RPR services are anticipated for a construction period of 12 weeks, for which part-time is defined as up to 40 site visits at up to nine hours per visit. Any services that include the review or analysis of unsolicited media including, but not limited to, photographs, videos, and drone footage provided by OWNER or contractors unless specifically requested and agreed to in writing are not included. ENGINEER's use of electronic construction administration programs (e.g., e-builder, Newforma) is limited to the Scope of Services defined in this Task Order. ENGINEER is not responsible for the review of unsolicited media uploaded to these programs unless specifically requested and agreed to in writing.

#### Compensation

OWNER shall compensate ENGINEER for Services under this Task Order on an hourly rate basis plus expenses an estimated fee of \$83,700.

#### Schedule

Services will begin upon execution of this Task Order, which is anticipated the week of June 9, 2025. Services are scheduled for completion on October 31, 2025.
